

Re-Match announces the result of its Initial Public Offering

Herning, Denmark, 17 December 2021 - With reference to company announcement no. 3/2021 dated 3 December 2021 as published by Re-Match in connection with the initial public offering (the "Offering") and admission to trading of Re-Match's shares on Nasdaq First North Premier Growth Market in Copenhagen, Re-Match today announces the results of the Offering.

Laurits Mathias Bach Sørensen, Chairperson of the board of directors of Re-Match, said:

"This is indeed a milestone for Re-Match, and I am very pleased to welcome all the new shareholders, whom I want to thank for their support and trust. The successful IPO is an acknowledgement of our patented recycling process of worn-out artificial turfs, which converts a significant, rapid growing waste problem into a sustainable business while significantly reducing plastic and CO2 pollution. I want to thank the entire Re- Match team for their efforts, in particular during the IPO process."

Nikolaj Magne Larsen, CEO and co-founder of Re-Match, said:

"The proceeds from the IPO will enable us to continue executing on our factory roll-out plan. The factory is already well under way in Holland, and we have already taken the initial steps for the French and first US factory. I am grateful and encouraged by the support we have seen from investors in the past weeks, and we will work hard to deliver on the expectations of all our new shareholders."

Highlights of the Offering

- A fixed offer price of DKK 16 per Offer Share of nominal value of DKK 1 each
- The Offering was well oversubscribed and attracted interest from both Danish and international institutional investors as well as from Danish private investors. Thus, the Offering is fully subscribed.
- 10,937,500 new shares (the "Offer Shares") in the Company each with a nominal value of DKK 1 have been subscribed for.
- As part of the Offering, the Sole Global Coordinator has exercised its right to overallot 1,250,000 shares, which is facilitated by Nordic Alpha Partners Fund I K/S under a share lending arrangement, and a corresponding overallotment option has been granted by the Company to the Sole Global Coordinator to subscribe for up to 1,250,000 additional shares (the "Option Shares"), exercisable, in whole or in part, until 21 January 2022. The overallotment option corresponds to 11.4% of the Offer Shares.
- Provided that the overallotment option is exercised in full, the Offering will comprise a total of 12,187,500 shares in the Company.
- Assuming that the Offering is completed, the Company expects to raise gross proceeds of DKK 175 million and, after payment of estimated IPO costs, approximately DKK 159 million in net proceeds (each excluding the Option Shares, if any).
- Following completion and settlement of the Offering, the free float is expected to amount to between 27.5% and 30.5% of the Company's share capital, depending on the potential exercise of the overallotment option.
- A group of investors (together the "Cornerstone Investors") and the Company's principal shareholder, NAP, and a group of existing shareholders (together the "Participating Existing Shareholders"), have been allocated Offer Shares at the Offer Price for an aggregate subscription amount of approx. DKK 150.7 million, corresponding to 86.1% of the Offer Shares (excluding the Option Shares).

- With respect to applications to subscribe for amounts of more than DKK 1 million, individual allocations have been determined by the board of directors of the Company.
- With respect to applications to subscribe for amounts of up to and including DKK 1 million, reductions have been made mathematically:

o Subscribers subscribing for less than or equal to 1,875 shares will receive full allocation

o Subscribers subscribing for more than 1,875 shares will receive 1,875 shares and 30% of the shares subscribed for above 1,875 shares

- Trading of the Offer Shares on Nasdaq First North Premier Growth Market in Copenhagen is expected to commence on 23 December 2021 under the symbol "RMATCH".
- The Company is expecting to register the capital increase from the Offering with the Danish Business Authority on 21 December 2021 increasing the share capital by 10,937,500 new shares of a nominal value of DKK 1. Additionally, the Company expects to register the capital increase from the conversion of loans to shares by the Converting Note Holders with the Danish Business Authority on 22 December 2021 increasing the share capital by 1,505,312 new shares of a nominal value of DKK 1. After the two capital increases the share capital comprises DKK 28,703,900 consisting of 28,703,900 shares of a nominal value of DKK 1.

Re-Match in brief

Re-Match is an artificial turf recycler headquartered in Herning, Denmark, where the Company also operates its factory. The Company's patented recycling process enables artificial turfs to be disposed in a sustainable way. Re-Match sources wornout artificial turfs, for which the Company is paid a gate fee. The Company then processes the turfs through its mechanical recycling process and subsequently sells the clean recycled output materials back to turf producers, installers as well as other industries – ready to be used in new production cycles.

Artificial turf is becoming increasingly popular as an alternative to natural grass as it facilitates doing sports anywhere, including in areas with adverse weather conditions and water shortage, while also accommodating more intensive use. The global installed base of artificial turf is estimated by AMI Consulting to ~370,000 full size soccer pitch equivalents by 2023. However, with a lifetime of around 8-12 years, disposal and replacement of turfs have become an imminent issue as traditional disposal methods mainly comprise landfill and incineration, which both have severe negative impact on the environment. As an alternative, Re-Match offers a long-term sustainable disposal solution reducing CO2 pollution and recycling plastic by which Re-Match is tapping into the global underlying mega trends such as the push for a greener agenda, circularity and the search for sustainable solutions to mitigate an appertaining waste problem.

Re-Match constitutes what it believes is the only artificial turf recycler with a third-party verification that handles the entire worn-out turf in a fully mechanical thermal process without the use of water or chemicals. In the process, the turf is downsized, dried, separated and cleaned resulting in four clean main output components without the creation of additional waste products. The recycled granulated grass fibres are used within a host of other industries and recycled by either compounding or pelletizing ready to be used in production of new plastic products, while the infill (sand and rubber) is reused in new turfs or in other applications such as sand blasting and in the production of rubber wheels and rubber mats.

Re-Match's mechanical process is granted the Environmental Technology Verification ("ETV") by the EU evidencing the Company's status as an eco-efficient technology. In addition to the ETV, Re-Match is accredited the ISO 9001, certifying the Company's quality and process governance which together with the ETV verification cement the Company's commitment to increase the standard and transparency in the artificial turf disposal and recycling industry. As of 30 September 2021, ReMatch's core artificial turf separation process and infill separation process were patent protected in a total of 42 and 33 different countries, respectively, where the patents are in force until 2033 and until 2034 outside EU and US.

As of 30 September 2021, the Company's factory in Herning, which became operational in 2016, has recycled 662 artificial turf pitches corresponding to \sim 116,000 tons of waste which is equivalent to saving \sim 520 million plastic bags and had 38 full-time employees.

Re-Match's ambition is to accommodate the increasing demand for sustainable artificial turf disposal and provide artificial turf owners and installers with a better, cheaper and simpler end of life solution for their worn-out turf. The Company's near-term factory roll-out plan comprising one factory in Tiel in the Netherlands, which currently is under construction, two in the United States, one in France and one in the UK – the latter two as joint ventures with local partners. The second factory in the US has been postponed such that it is expected to have its first full operational year in 2026.

The new factories are designed based on key learnings from the factory in Herning. A fully operational factory is expected to generate annual adjusted revenues (non-IFRS) in the range of EUR 10-13 million and deliver adjusted EBITDA (non-IFRS) in the range of EUR 3-5 million subject to uncertainty and depending on location. The new optimised factory blueprint has an annual capacity of 250 pitches and a payback period of \sim 3-5.5 years as well as a fully replicable ERP system.

Re-Match is currently owned by Nordic Alpha Partners Fund I K/S, the two co-founders, members of the management team, the Board of Directors and several other minority shareholders.
